Gordon Hospital conducted and participated in a broad Community Health Needs Assessment (CHNA) during 2013. See the final plan at www.gordonhospital.com.

Gordon Hospital was a leader in the development of the Community Health Needs Assessment. Other participants included the Gordon County Health Department, Gordon County Hospital Authority Board, Gordon Hospital staff, and community agency representatives.¹ The Assessment looked at the health-related needs of the broad community as well as those of low-income, minority and underserved populations. The Assessment included both primary and secondary data, and identified the following priorities:

- Cancer programming and screening education
- Lack of healthcare provider access in Fairmount
- Heart disease and stroke
- Respiratory diseases and smoking

The hospital's Community Health Needs Assessment Committee participants, hospital leadership and hospital board reviewed the needs identified in the Assessment. The hospital board approved the priorities and the full Assessment.

Next, with focus on the above priorities, the Community Health Needs Assessment Committee helped develop a Community Health Plan². The Plan has been approved by the Gordon Hospital Board and posted by May 15, 2014 at the web location noted below. The Plan lists targeted interventions and measurable outcome statements for each effort. Many interventions engage community partners.

Gordon Hospital's fiscal year is a calendar year (January – December). For 2014, the Community Health Plan³ will begin May 15 and evaluated at the end of the calendar year. In 2015 and 2016, the Community Health Plan will be evaluated annually for the 12-month period beginning January 1 and ending December 31. Evaluation results will be posted annually and attached to our IRS Form 990.
